The Town Council of the Town of Mineral Springs, North Carolina, met in an Organization Meeting and a Regular Session at the Mineral Springs Town Hall, Mineral Springs, North Carolina, at 7:30 p.m. on Thursday, December 8, 2011.

Present: Mayor Frederick Becker III, Mayor Pro Tem Jerry Countryman, Councilwoman

Valerie Coffey, Councilwoman Janet Critz, Councilwoman Lundeen Cureton, Councilwoman Peggy Neill, Town Clerk/Zoning Administrator Vicky Brooks and

Deputy Town Clerk Janet Ridings.

Absent: Attorney Bobby Griffin and Councilwoman Melody LaMonica.

Visitors: Charles Bowden and Chief Donald Gaddy.

With a quorum present Mayor Frederick Becker called the Regular Town Council Meeting of December 8, 2011 to order at 7:35 p.m.

1. Opening

- Councilwoman Critz delivered the invocation.
- Pledge of Allegiance.

2. Organizational Meeting

Mayor Becker opened the Organization Meeting at 7:38 p.m.

A. Reading of votes from the regular election held on Tuesday, November 8, 2011.

Town Clerk Vicky Brooks read the votes from the November 8, 2011 election as received from the Union County Board of Elections: <u>Mayor</u> - Frederick Becker – 228, Charles Bowden – 118; <u>Council</u> – Valerie Coffey – 258, Lundeen Cureton – 243, Peggy Neill – 253.

B. Administer the Oath of Office to Mayor and Council Members

- o Ms. Brooks administered the Oath of Office to Mayor Frederick Becker, III.
- Mayor Becker administered the Oath of Office to Councilwoman Valerie Coffey, Councilwoman Lundeen Cureton and Councilwoman Peggy Neill.

C. Nomination and appointment of Mayor Pro-Tempore

 Mayor Becker opened the floor for council discussion and nomination on the Mayor Pro-Tempore position.

- o **Councilwoman Neill** made a **motion** to nominate Councilwoman Coffey as Mayor Pro-Tempore and **Councilwoman Cureton** seconded.
- Councilwoman Critz confirmed with Councilwoman Coffey that she wanted to run. Councilwoman Coffey responded that she would be honored.
- Councilman Countryman made a motion that nominations are closed and Councilwoman Cureton seconded. [This motion and second were not voted on]
- Mayor Becker called for a vote on the motion to nominate Councilwoman Coffey as Mayor Pro-Tem by Councilwoman Neill. The motion passed unanimously as follows:

Mayor Becker closed the Organizational Meeting at 7:45 p.m.

and **Councilman Countryman** seconded. The motion passed unanimously as follows:

Ayes: Coffey, Countryman, Critz, Cureton and Neill

Nays: None

5. <u>Consideration of Appointing Council Members as Delegate/Alternate to</u> Centralina Council of Governments (COG)

- Mayor Becker queried if Councilwoman LaMonica was the current COG delegate and noted that she had emailed to say that she was unavoidably out of town again and is excused from this meeting. Mayor Becker asked if anybody wished to volunteer to be the COG delegate. Councilman Countryman encouraged Councilwoman Cureton to take this opportunity and asked if she would consider it. Mayor Becker explained that it is a good networking opportunity occurring three or four times a year in various locations, which can be as far away as Hickory. This may be difficult for Councilwoman Cureton especially since they are evening meetings, unless one of us is willing to go with her if it is far away. Mayor Becker noted that an alternate was needed also.
- Councilwoman Critz made a motion to nominate Councilwoman Cureton as delegate and Councilwoman Neill as the alternate. Councilwoman Critz clarified with Councilwoman Cureton that Mayor Becker and she would volunteer to travel

with her. Mayor Becker noted that it is an open meeting, so you do not have to be a delegate or alternate to attend. Councilwoman Neill also volunteered to attend Councilwoman Cureton asked when the meetings with Councilwoman Cureton. were. Mayor Becker responded that they were in the evening about four times a Councilman Countryman offered that the meetings were on Wednesday. Councilwoman Coffey also responded that it was between Tuesday and Thursday, they last about an hour and a half and dinner is included, in addition, the delegate is reimbursed with a \$20 to \$25 check for attending. It gives delegates an opportunity to get involved in some of the committees that go to the State Legislature and lobby for things that they want. Councilwoman Cureton agreed to Mayor Becker reminded the council of the motion by attend the meetings. Councilwoman Critz to appoint Councilwoman Cureton as our delegate. **Councilman Countryman** seconded the motion. The motion passed unanimously as follows:

6. <u>Consideration of Mayor/Council Attending the Essentials of Municipal</u> <u>Governments</u>

- Mayor Becker pointed out that the Essentials of Municipal Governments class information was in the agenda packet; it explains what the requirements are. The full class is available, but he was really interested in the alternative one for returning council members, which is the planning and zoning class. alternatives give the two-hour credit for the mandatory ethics training. Mayor Becker pointed out that every time you are elected you have to take the ethics training within 12 months; therefore Councilwoman Critz, Councilwoman LaMonica and Councilman Countryman are not required to take it at this time, although there is no reason why they wouldn't necessarily consider it a benefit. Mayor Becker commented that a budget amendment would be needed if every council member were going to do three nights and the full class, but he didn't think the council would object to that. The council can look at their calendars to see what works best for them and then notify Ms. Brooks of their interest, remembering that the four who have been elected should do this now rather than have to do ethics training later.
- Councilwoman Critz made a motion that we leave this to the individual council member and mayor to decide what works best with their calendar and their time and then come back to the council and let us know if a budget amendment is necessary, we do it at that time, if not, then it is covered and Councilman Countryman seconded. The motion passed unanimously as follows:

7. <u>Discussion on a Joint Meeting with the Union County Board of Commissioners</u> and Consideration of Calling for a Special Meeting

 Mayor Becker reminded the council that a joint meeting with the commissioners was held about two and a half years ago and at the time one of the items that was discussed was sewer access for the town. The Union County Board of Commissioners and County Manager Cindy Coto would like for us to come up with some ideas of things we feel we want to discuss with the commissioners. Mayor Becker stated that sewer is still big. The good news is that Mayor Becker and Ms. Brooks met with Chairman Simpson, Commissioner Johnson and Public Works Director Ed Goscicki on Monday afternoon and the way it stands now, they have not finalized the plan yet, but they are willing to lay the pipe from the sewer crossing down at the bottom on the way to Parkdale where is crosses Highway 75, basically to the center of town, at the expense of the County Utility Department with no reimbursement from the town or the businesses. This would be a huge benefit; we have been asking for that for years, and suddenly they are dropping it in our lap. However, there is a catch and it is something that we will discuss at the meeting on the 12th [of January]. Mayor Becker and Ms. Brooks have already discussed bringing members of the public who own businesses or property in that downtown service area. A specific number wasn't given, but Commissioner Johnson specifically wanted to know that we had some current interest (businesses) who really want to hook-up right away. Ms. Brooks has done some unofficial canvassing and the Petro/Kangaroo obviously needs service and is interested. Spiro [Kaltsounis] may open a restaurant within six months of having sewer service; he has been pretty gung-ho about it and he makes money selling food, not sitting on vacant shopping centers, so he may take that opportunity. They [commissioners] did not give a number, but they want more than one or two. We will talk with Chief Gaddy and his board, and the church. Mayor Becker pointed out the church's needs have turned out to be less than they thought they were and they may not be wanting to hook up right away. Councilman Countryman responded that he can't imagine that, given the opportunity. Mayor Becker explained that hooking up to sewer is quite expensive in the county, the residential hookup or the three-quarter-inch meter commercial hookup is \$2,650 (capacity fee), then there is a cut-in fee that a customer pays the backhoe guy to actually hook up to the pipe. which can cost \$600 to \$800 depending on the size of the sewer pipe, and then there is the customer's own obligation to run from his building out to the street (which his own plumber has to do). It costs money and people have to be aware of that. Then they are paying monthly based on their water meter size and their water consumption. Councilman Countryman asked if the people that could get hooked up were the ones that currently have county water service or that will have to have Mayor Becker responded that these were the kind of county water service. questions that we can ask the commissioners and Ed Goscicki about at the joint meeting. Mayor Becker wants to have people here so they are getting first-hand answers from county officials; for example, he does not know if a customer on a well can get sewer service. Mayor Becker added that most commercial meters are bigger than three-quarter inch; for a one inch meter (like the town has), he believes the capacity fee alone is up in the \$6,000 range or something. If you go to an inchand-a-half meter it is up there in the \$13,000 range; that is a one-time up-front fee. Then the monthly charge keeps creeping up. Some users, like the church, have three meters; they have an inch and a half, inch and a half, and a two inch, so the pastor said "you know we are talking \$50,000 in capacity fees just to hookup". Other users that have a sprinkler system have a "monster" line coming in and Mayor Becker does not think that it could based on a six inch line; these are

technical questions that Public Works Director Ed Goscicki could explain to the board. Mayor Becker stated that he thought this was good news no matter how you look at it and he hoped that we could get enough interest so as not to delay it. Mayor Becker will get in touch with Larry Raley to try to get him on board to look at striking while the iron is hot. Mayor Becker explained that he and Ms. Brooks are working on getting the notification out to the downtown community and asked the council for a motion to call for the special joint meeting at 6:00 p.m. prior to our next regular meeting at 7:30 p.m. Councilwoman Critz suggested a little housekeeping note that she thought the town should have some form of refreshment as a hospitality effect.

 Councilman Countryman made a motion to have a special meeting on January 12, 2011 at 6:00 p.m. (with refreshments) for the purpose of conducting a joint meeting with the Union County Commissioners and Councilwoman Neill seconded. The motion passed unanimously as follows:

Ayes: Coffey, Countryman, Critz, Cureton and Neill

Nays: None

 Mayor Becker asked the council if they had anything they wanted to tell County Manager Coto that they want to talk about with the commissioners aside from the sewer project. Councilwoman Coffey responded that she thought that was a priority.

8. Consideration of a Resolution for a Carolina Thread Trail Grant Application

- Mayor Becker explained that he realized Monday morning at 6:00 a.m. that the
 deadline for this application is January 6, 2012; the council has to adopt a
 resolution and approve of applying for the grant. Mayor Becker pointed out that he
 had not yet completed the last two pages of the application (most of it is technical),
 but he would complete that information. Mayor Becker asked the council if they
 had any suggestions of changes. Councilwoman Critz responded that she thought
 he had done a great job.
- Councilman Countryman made a motion to adopt the resolution seeking the grant from the Carolina Thread Trail and Councilwoman Critz seconded. The motion passed unanimously as follows:

TOWN OF MINERAL SPRINGS

RESOLUTION OF COMMITMENT TO A TRAILHEAD PARKING FACILITY AND INTENT TO SEEK CAROLINA THREAD TRAIL GRANT FUNDING

R-2011-03

WHEREAS, the Town of Mineral Springs has had a long-term commitment to trail and greenway development for the community; and

WHEREAS, the town has already acquired over 65 acres of riparian land, placed conservation easements on this property, and developed trails on this property; and

WHEREAS, the town has actively participated in the development of the Carolina Thread Trail master plan for Union County; and

WHEREAS, a two-mile portion of the town's trails has been designated as a Carolina Thread Trail segment in the master plan;

WHEREAS, the town formally adopted the Carolina Thread Trail master plan on May 12, 2011; and

WHEREAS, the Mineral Springs Town Council has approved development of a McNeely Road trailhead and parking area in order to make the trail more accessible to the public and establish a "hub" for the town's segment of the Carolina Thread Trail; and

WHEREAS, the Mineral Springs Town Council approved engineering expenditures of \$900 for this facility by motion on December 9, 2010, and approved construction expenditures of \$75,370 for this facility by capital project ordinance on August 11, 2011, for a total commitment of \$76,270; and

WHEREAS, the Carolina Thread Trail has made grant funding available for construction of trails and related facilities; and

WHEREAS, the Mineral Springs Town Council believes that the McNeely Road trailhead and parking area will make a significant contribution to the overall success of the Carolina Thread Trail in Mineral Springs and Union County;

NOW, THEREFORE, BE IT RESOLVED that the Town of Mineral Springs hereby restates its commitment, including its financial commitment of \$76,270, to the development of the McNeely Road trailhead and parking area;

AND BE IT FURTHER RESOLVED that the Town of Mineral Springs hereby expresses its intent to apply for Carolina Thread Trail grant funding in the amount of \$35,000 to be used to offset a portion of the cost of development of the McNeely Road trailhead and parking area;

AND BE IT FURTHER RESOLVED that the Town of Mineral Springs authorizes Mayor Frederick Becker III to submit a grant application and all associated supporting documentation to the Carolina Thread Trail for the purpose of securing this \$35,000 construction grant.

 Mayor Becker reported that he saw Travis Morehead today when he, the clerk and Lisa Tompkins (trail committee member) attended a Carolina Thread Trail work session in Mooresville from 9:00 a.m. to 4:15 p.m. Mayor Becker informed Mr. Morehead that the grant would be on the way.

9. Other Business

- Councilwoman Critz reported that she and Mr. Critz attended the Chamber of Commerce Annual Meeting on December 1, 2011 held at the Agricultural Center; it was the best-attended annual meeting for the Chamber. Councilwoman Critz commended Sharon Rosche for her work in revitalizing the Union County Chamber of Commerce.
- Councilwoman Critz she. Councilwoman announced that Councilwoman Neill attended the ribbon cutting at the new Carolinas Medical Center Emergency Health Facility in Waxhaw. Nancy McCoy Duncan from the Chamber approached Councilwoman Critz during this event to state how grateful they were that she attended the dinner [annual meeting] and for her support. Councilwoman Critz explained that the support was extremely minimum, but it did not go unnoticed; this council should reach out to our neighboring towns/council members/mayors to let them know how much the Chamber is appreciating participation and support in an effort to encourage others. Councilwoman Critz reminded the council that during a training business luncheon she once attended, the Chamber expressed interest in Mineral Springs for hosting a coffee morning gathering, business gathering or teaching lunch time; with Ms. Brooks' help Councilwoman Critz would like to contact Theresa [Byers] to see if we can get Mineral Springs on their calendar for hosting something sometime.
- Councilwomen Critz, Coffey and Neill continued describing their attendance at the new Emergency Health Center. This is the second facility in the State of North Carolina like this; the emergency department is state-of-the-art, which goes beyond urgent care. They have a meeting room available if the council ever needs a larger facility; anyone in the community can get on the calendar to use that room (i.e. churches). All of the artwork in the facility is either local artists or photographs of local landmarks. This facility is bringing in jobs; 75 from the emergency side of it, the doctors' offices are a private enterprise, so it is a joint operation. Yearly, \$6,000,000 is being added to the county budget from this benefit. The facility will have a helicopter pad for any real emergencies. The imaging center will do ultrasound, x-rays, cat scans and they are hoping to add mammograms and MRI's to it at some point. The space that is there hasn't been built out with the anticipation that they will expand. Councilman Countryman asked Mineral Springs Fire and Rescue Department Chief Donald Gaddy if this is where they were going to take folks instead of CMC-Union. Chief Gaddy responded that a lot of the time they take them where the patient requests, but this will be a lot shorter ride on that backboard than CMC downtown. The facility opens officially on Monday, December 12, 2011.
- Councilman Countryman explained that he had received a couple of comments by people in the community regarding our Christmas season and their disappointment in the town's participation. Mineral Springs is dramatically being outdone by our neighbors in terms of how "Christmassy" we look (Waxhaw is beautiful). Councilwoman Neill agreed that it is time for the town to do something.

Councilman Countryman continued that sadly, not only are we probably not as attractive as we could be, but what we do have in some cases is not functioning. Councilman Countryman suggested that the town needs to take a serious look at where we want to be in the future. Ms. Brooks noted that she was going to "beg" the council this year; it was on her agenda! Councilman Countryman suggested that the building out there could be lit and we have a whole string of trees here in the parking lot that could be lit. Councilman Countryman noted that he was just saying that they need to take a serious look at how they can do better next year for Mayor Becker responded that Ms. Brooks and he recently our community. discussed the lights (outdoor displays) that we have, which have reached the end of their useful life; two years ago, Ms. Brooks, Christina and he spent the better part of a week, (several hours a day) literally changing every bulb and getting all the lights functional again. This year, they were to the point that it wasn't bulb replacement anymore, strings have gone bad and so the babying we have to do just to get them to mostly light up has really become so labor intensive that they really have reached the end of their service life. Councilman Countryman added that if you look at it from the point of view of some of our citizenry, we can spend thousands of dollars to create a parking lot, but we don't seem to look at other issues where we could spend some money that maybe would benefit more people. Mayor Becker suggested that at the January or February meeting he would like to put together an agenda item so we can really get somebody on the council tasked to start looking at alternatives for better Christmas displays downtown.

- Mayor Becker reminded the council that Ms. Brooks and Ms. Janet Ridings would be going to clerks' school on January 23rd, 24th, & 25th and he had pledged to be able to keep the office open; however, he may have a conflict on the 23rd and if that happens, the office will have to be closed. There was a consensus of the council that notification be posted that the office is closed due to training.
- Mayor Becker explained that he would not normally bring this up at an official meeting, but he thought that it was incumbent upon him to do so, because Mr. Bowden made an accusation in an official meeting that was 100% false and "if he hired a private investigator, he needs to get his money back". The incident Mr. Bowden referred to [under public comment] accused Mayor Becker of being charged with burglary in 1986. Mayor Becker stated that he has never been charged with burglary (he said he wanted to look each council member in the eye) anywhere in any jurisdiction in this country or world. Mayor Becker further stated that he would tell the people in the community if they ask him. Mayor Becker reiterated that he was never charged with burglary. Councilwoman Coffey offered that she had never entertained any of his [Mr. Bowden's] comments. Becker explained that he wanted to be able to say that with a straight face truthfully, because he is one for accuracy - when he has made a mistake in his past or when he makes a mistake on the agenda, he will be the first to admit it. Councilwoman Coffey commented that she is still trying to figure it out - Mr. Bowden has also said that the town pays him \$40,000 or \$50,000 a year, "this is all the same lie". Mayor Becker responded that there were many errors and lies in "that" letter "you all" got from him. Councilwoman Critz added that he [Mr. Bowden] was saying that Mayor Becker was hiding a past felony and that the council all knows, and even though they swear to uphold the law, they aren't upholding the law because they've allowed Mayor Becker to do that. Councilwoman Critz

explained that she and Mayor Becker took a concealed weapons class together, they went through the Union County Sheriff's Department, were fingerprinted and had a thorough background check. Councilman Countryman added that that background check is the NCIC [national] fingerprint check. Councilwoman Critz announced that she and Mayor Becker have concealed weapons permits, which means they have never committed a felony.

- Councilwoman Neill explained that she received a phone call asking about the junk vehicles in the downtown overlay and asked Ms. Brooks if the planning board was addressing this issue yet. Ms. Brooks responded that something has been done about this issue and all she needs is something in writing. Councilman Countryman responded "have the resident write a letter".
- Councilwoman Cureton stated for the record that she was falsely accused of road rage, "I did not run into that man [Charles Bowden]". Councilwoman Cureton explained the he proceeded to make a turn; he put his right signal on to turn right and the minute she started around him he ran into her. Councilwoman Cureton stated that she spoke with a lawyer [about the incident], who advised her to leave it alone, because "the man is crazy".

10. Adjournment

 Councilman Countryman made a motion to adjourn and Councilwoman Coffey seconded. The motion passed unanimously as follows:

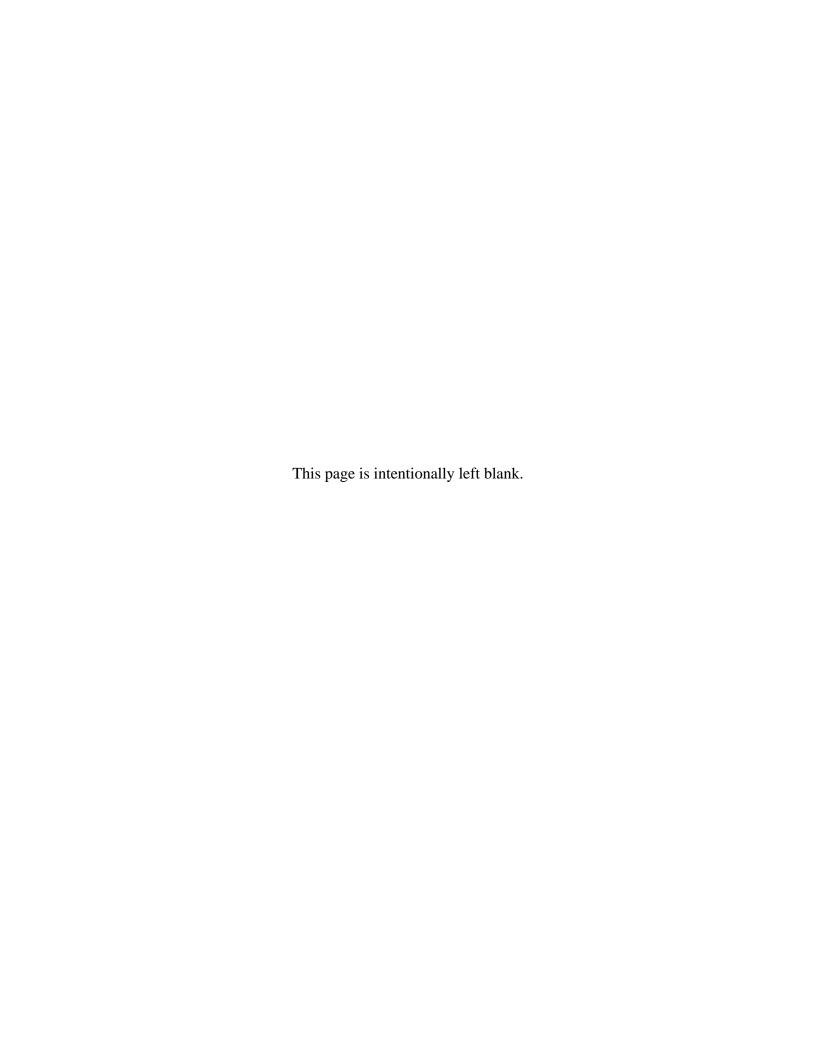
