### Craft Vendor Definition

Any individual, home-based business or not-for-profit entity interested in selling or showcasing their handcrafted work or products to the public.

### Vendor (other) Definition

For profit business entity interested in selling or showcasing their products. (i.e. health & beauty products, Tupperware).

### Exhibitor Definition

A company purchasing a 10 x 10 space to advertise their business at the festival.

### Craft Vendor / Vendor (other) / Exhibitor Guidelines

1. Awarded spaces are non-transferable
2. Spaces are 10 feet x 10 feet and additional space must be purchased if needed.
3. This is an outdoor event and no refunds for inclement weather will be given.
4. **Craft Vendors / Vendors (other) / Exhibitors must provide their own tents, tables, chairs and tent tie downs. Tents and tie downs are mandatory.**
5. Craft Vendors / Vendors (other) / Exhibitors must be present during the entire event and must personally staff their space. Craft Vendors / Vendors (other) / Exhibitors not arriving by 9:00 a.m. Saturday morning will be considered a NO SHOW. **Craft Vendors / Vendors (other)/ Exhibitors must not break down before 4:00 p.m. at the conclusion of the event.**
6. Craft Vendors / Vendors (other) / Exhibitors are responsible for maintaining and leaving their area free of refuse. Every craft vendor / exhibitor will be given a trash bag. Please leave it in the center of your space or in the closest trash receptacle at the conclusion of the event.
7. Craft Vendors / Vendors (other) Exhibitors shall refrain from the use of tobacco products (i.e. smoking, chewing tobacco, etc.) while in their space.
8. **Exhibitors** must not provide free water/beverages to the patrons of the festival as we have food vendors onsite selling these items.

### Craft Vendor / Vendor (other) / Exhibitor Agreement

Applicants shall indemnify and hold harmless the Town of Mineral Springs, its agents, volunteers, elected officials and employees from and against all losses, costs, damages, expense, and liability caused by an accident or other occurrence in bodily injury, including death, sickness and disease to any persons, or damage or destruction to property, real or personal, arising directly or indirectly from operations, products or services rendered at this event.

Applicant agrees to waive, release or discharge the Town of Mineral Springs, its agents, volunteers, elected officials and employees, of and from any and all claims, demands, costs, liability and causes of action whatsoever that may arise as a result of participation in this event, including but not limited to, any claims, cause of action, liability, damages, demands and costs related to injury to the benefit of Town and shall bind Applicant along with its employees, heirs, legal representatives, assigns and successors in interest of the Applicant or any member thereof.
